## **Promotion Description**

### Competitive Acquisition CC + LD BUN 39 Extension #1497

#### <u>Overview</u>

The Competitive Acquisition CC + LD BUN 39 Extension promotion is extended to 12/31/2007. Competitive Acquisition customers subscribing to the BellSouth (R) Complete Choice (R) bundle and any BSLD product (except BellSouth(R)unlimited long distance) will receive a \$5.00 discount.
