Line Connection Fee Waiver (E-Store)

Overview

The Line Connection Fee Waiver promotion is extended beginning on October 1, 2007 and end on April 30, 2008. Residential customers who place an online order to move their service to a new location will have the line connection charge waived.

Promotion Specifics

Customers who place an online order to move their residential service to a new location will have the line connection charge waived.

Customers must place their order via BellSouth.com.

Promotion Restrictions/Eligibility Requirements

1. Only available for existing residential customers placing a T-order through BellSouth.com

2. Only available to existing residential customers transferring their service through the online channel and establishing residential phone service.

3. Incomplete orders placed through the website do not qualify for the connection fee waiver.

4. This offer runs from October 1 2007 through April 30, 2008. All orders must be placed no later than April 30, 2008 to qualify for the promotional offer.
