Service Connection Charge Waiver Extension

Overview

The Service Connection Charge Waiver promotion is scheduled to begin on 12/22/2008 and end on 12/21/2009. The Line Connection Charge may be waived for customers who subscribe to Complete Choice Basic or any other package or service that contain those elements. It can also be waived for customers who subscribe to basic local service plus two nonzero rated features.

Promotion Specifics

Service connection charges may be waived for acquisition customers who subscribe to Complete Choice Basic or any other package or service that contain those elements. It can also be waived for customers who subscribe to basic local service plus two nonzero rated features.

Promotion Restrictions/Eligibility Requirements

Offer Criteria:

1. Customer must have at least one wireline local service or equivalent (wireless in lieu of wireline) with a provider other than AT&T at a local service address with in the AT&T territory.
2. The customer must select AT&T as their local service provider.
3.
