The purpose of this filing is to introduce two new Sprint SolutionsSM packages for business customers, Economy Solution II and Rotary Classic Solution.

In addition, Sprint is introducing a new option for business customers subscribing to the Sprint SolutionsSM Package, Sure Solution II. The new option allows customers to include all mandatory expanded local calling (25/25 Plan and measured/message ECS/EAS) for a single flat rate. Customers subscribing to the expanded local calling option must also purchase the Company's Voicemail Service and Sprint Communications L.P. Sprint Small Business UnlimitedSM Solutions Long Distance Plan. Sprint is also adding clarifying language to the footnote regarding the Monthly Rate.

Rotary Hunt Service, as defined in Section A3, is not available in conjunction with the Plan **unless Rotary Line Service is included in a specific Sprint SolutionsSM Package. The Plan cannot terminate to a Key System or PBX.**
- d. No more than four (4) business lines can be enrolled with the Sprint SolutionsSM option for each customer Billed Telephone Number account.
