Currently 34 residential customers within the Lost Lake Pines development (Winter Garden exchange) are being served from the Clermont exchange. This transfer will serve to realign the exchange boundary to agree with the actual provision of service and to allow the exchange boundary to follow private property boundaries as indicated on plat records in Lake County.

Two additional developments, Southern Pines and Hartwood Reserve, will be served wholly within the Clermont exchange with this exchange boundary change and will ensure future development of this property will keep the community of interest in one exchange. There are no customers impacted by these changes. This filing will cause no change in customers' rates or services.



CLERMONT EXCHANGE



WINTER GARDEN EXCHANGE


