This filing proposes to change the exchange boundary of Eustis, Mount Dora and Tavares.

Currently the housing development of Lake of Mount Dora falls within the Mount Dora and Eustis exchanges. This change will ensure future development of these properties will keep the community of interest in the single defined exchange of Eustis. This change will not have an impact on existing customers' rates or services.

In addition, there are currently fifteen customers in the Mount Dora exchange located in the East Lake Joanna area being served cross boundary from the Eustis exchange. This boundary transfer will serve to realign the exchange boundary to agree with the actual provision of service and will have no customer impact since these customers will retain current rates and services.

Additionally, the housing development of Misty Meadows falls within the Mount Dora and Tavares exchanges. This change will ensure future development of this property will keep the community of interest in the single defined exchange of Tavares. This change will not have an impact on existing customers' rates or services.



EUSTIS EXCHANGE





MOUNT DORA EXCHANGE





EUSTIS EXCHANGE




