AA. TERM DISCOUNT PLAN (TDP) FOR BUSINESS KEY LINES AND PBX TRUNKS (Limited service offering)

#### 1. General

- a. A Term Discount Plan (TDP) provides customers with discounted rates for Business Key Lines, Business Rotary Key Lines, and PBX Trunks for the Apopka, Astor, Clermont, Eustis, Groveland, Howey in the Hills, Kenansville, Kissimmee, Lady Lake, Leesburg, Montverde, Mount Dora, Reedy Creek, Saint Cloud, Tavares, Umatilla, West Kissimmee, Windermere, Winter Garden, and Winter Park exchanges. This is a discount off of Business Key Lines, Business Rotary Lines, and PBX Trunks found elsewhere in this tariff. This tariff will be effective for a market trial period from March 1, 2003 through February 28, 2004.
- b. Business Key Lines, Business Rotary Key Lines and PBX Trunks may be ordered under a TDP for fixed periods of two (2) years and three (3) years.
- c. The customer must specify the length of the initial service period at the time the service is ordered.
- d. At the end of the TDP the customer may subscribe to a new TDP at the prevailing rates set forth in A13.AA.3. following. If the customer does not specify renewal terms in writing 90 days prior to the expiration of the two year or three year service period, the commitment period and the rates in effect at the time of expiration will automatically be extended for an additional 12 months. The customer can terminate service at the end of the minimum commitment period with no penalty or obligation to continue the service.
- e. Rate increases or decreases will automatically be applied to the monthly term plan rates for the remaining term of the TDP. If a Company initiated rate increase causes the services under the TDP to increase by 10% or more annually, then the customer may cancel the TDP without incurring termination liability charges provided the customer notifies the Company within 30 days after the effective date of the rate increase.
- f. The customer can extend TDP commitment periods at any time during the term of the plan, up to a maximum of three years. The number of remaining months in the original term plan will become part of the total term in the new term plan.

This market trial allows the Company to quantify potential customer demand, further define the service offering based on customer feedback, and determine the viability of the service as a permanent offering. The dates for this market trial are from March 1, 2003 through February 28, 2004.
- Two Year TDP monthly rates will be provided at a 10% discount off of the Business Key Line, Business Rotary Key Line, and Trunks Flat Rate monthly rates specified in Section A3 of the tariff.
