 - 4) Up to 100 Direct Inward Dial (DID) Numbers (in blocks of 20) -Optional
 - 5) Unlimited Extended Area Service (EAS) and Unlimited Extended Calling Scope (ECS) calls.
 - 6) ISDN-PRI II Standard Features
 - 7) Customers must subscribe to the Sprint Long Distance Embarq Communications, Inc. 5,000 Minutes Block of Time.

3. Regulations

- a. Unless specified otherwise in this section, the regulations for ISDN-PRI II Service, including Service Connection Charges, set forth in Section A29, apply in addition to the regulations herein.
- b. Unless specified otherwise in this section, the regulations for DID Service, including Non-recurring and Installation Charges, set forth in Section A16, apply in addition to the regulations herein.
