This filing is being submitted to request a boundary transfer from the Lehigh Acres exchange to the Fort Myers exchange to accommodate The Fountains development which is a multi-use development planned for a 2,769-acre site in Lee County located off State Road 82. The development straddles the Fort Myers and Lehigh Acres exchange boundaries. There are no existing services in this block of land today. The Fountains is scheduled to be built in two phases from late 2007 to 2016, and will include 4,215 single and multi family living units, 600,000 square feet of retail space, 300,000 square feet of office space, and a 1.5 million-square-foot research and flex space district.

The Fort Myers exchange is the preferred community of interest for The Fountains development. The Fort Myers exchange will provide customers with a more expanded local calling area than the Lehigh Acres exchange. Changing the Exchange Tariff boundary will bring the entire community of The Fountains into the same community of interest (the Fort Myers exchange). Estimation of the number of customers to be impacted by these changes is zero. There are currently no customers working in this area today, therefore there will be no need to change phone numbers or dialing plans.






