This filing deletes references to unlimited measured/message ECS/EAS as a component of certain Solutions-Residence Packages and clarifies instances in which ECS/EAS charges apply in addition to business bundles. This filing standardizes and clarifies the availability of Anonymous Call Rejection (ACR) with Caller ID for each package and bundle. ACR is a component of the package or bundle due to its inclusion in the Caller ID feature. Several additional revisions are proposed for clarification and consistency, none of which are customer impacting and none of which change the manner in which services are provided.
