This filing eliminates the availability of the Talking Call Waiting feature for residence and business customers.

The manufacturer of the network software and hardware platform that supports the Talking Call Waiting feature or functionality discontinued support of the platform as of December 31, 2009.

The hardware components were discontinued by the manufacturer and are unavailable in the open market, as well as being proprietary. The Company no longer has an inadequate stock of spare hardware components to maintain the network platform and the underlying Talking Call Waiting feature functionality.

The cost to migrate the small number of customers who subscribe to Talking Call Waiting or the feature functionality to an alternative Company infrastructure is prohibitive. In addition, the discontinued support from the manufacturer has led to sporadic outages resulting in some Talking Call Waiting subscribers being adversely affected.
