3. Service Area

3.1 Exchange Areas for Residential Services

3.1.1 Residential

Sprint provides residential Local Exchange Service in the areas as defined below, where necessary underlying network elements are reasonably available to the company on terms that are both technically and economically feasible. As technical and/or economic feasibility allows, this section will be modified to reflect additional areas in which Sprint will offer local exchange service.

Sprint provides residential Local Exchange Service, as specified in Section 4, in all or portions of those BellSouth exchange Serving Wire Centers identified as UNE Zones 1 and 2.

3.2 Exchange Areas for Business Services

3.2.1 Rate Groups 1 and 2

The Company will provide business Local Exchange Service in the areas as defined below, where suitable facilities exist and where ordering and billing capabilities and the resale of necessary underlying network elements are technologically available and operationally and/or economically feasible.
