#### Re: Preferred Long Distance, Inc. (TX959), Tariff Advice Letter No. 11

Dear Ms. Salak:

Pursuant to the Federal Communications Commission's ("FCC") *Report and Order and Further Notice of Proposed Rulemaking* in Docket Nos. WC Docket No. 10-90, *et al.*, FCC 11-1611, *Second Order on Reconsideration* in Docket Nos. WC Docket No. 10-90, *et al.*, FCC 12-47,2 and Section 51.911 of the FCC's rules, 47 C.F.R. §51.911, attached for submission to the Florida Public Service Commission ("Commission") are amended Sheet Nos. 2, and 41 to Preferred Long Distance, Inc.'s ("Preferred") switched access price list, Florida P.S.C. Price List No. 2, for incorporation into the Company's Price List.

With this submission, Preferred complies with the above cited order and rule by reducing terminating end office access rate elements by one third the difference between the current rate and \$0.0007, in accordance with Section 51.907 of the FCC's rules, 47 C.F.R. §51.907, applicable to Preferred's underlying price cap incumbent local exchange carriers, through reference to the Company's F.C.C. Tariff No. 1. Further, Preferred reduces VoIP-PSTN traffic rates consistent with its terminating access rate reductions, also through reference to the Company's F.C.C. Tariff No. 1.
