


Dear Mr. Cohen:

The Commission's Division of Records and Reporting has notified me that mail to the address on file with us has been returned by the US Postal Service (USPS) stamped "return to sender" and "forwarding order expired." However, the USPS did stamp the forwarding address in Tarzana on the envelope.

Rule 25-24.520, Florida Administrative Code, Reporting Requirements, provides that pay telephone companies must provide the Commission with updated address, telephone, and liaison information within 10 days of a change. It has been longer than 10 days since the mail was returned, therefore, it appears you are in violation of this rule.

Normally, there is a \$500 fine associated with this rule violation. However, before I open a docket, I wanted to give you an opportunity to file the required updated information. 
