251(b)(5) of the Telecommunications Act of 1996 ("Act"). US LEC exchanges such traffic with incumbent local exchange carriers in Florida according to interconnection agreements under the Act. Thus, the Commission's decisions in this proceeding, which are anticipated to have general applicability, affect US LEC's substantial interests, entitling US LEC to participation with intervenor status as a matter of law.
