Dear Ms. Bayó:

On behalf of PaeTec Communications, Inc. ("PaeTec"), this letter responds to Commission Order No. PSC-00-0442-PAA-TP, issued in the above referenced docket, which directs Campuslink Communications Systems, Inc. d/b/a Parklink Communications, Inc. ("Campuslink") to return its Certificates No. 5749 (ALEC) and No. 5750 (IXC) to the Commission ("Order").¹ PaeTec and Campuslink were recently merged as part of an intra corporate merger, which was approved by the Commission in the above referenced docket. PaeTec, as the survivor of the merger, files this response to comply with the Order.

Although the Commission granted Campuslink Certificates Nos. 5750 and 5749, Campuslink did not receive physical certificates evidencing such authority. Pursuant to discussion with Commission staff, it is the understanding of PaeTec's undersigned counsel that the Commission ceased to issue physical certificates prior to granting Campuslink certification. Therefore, no certificates can or will be returned to the Commission.
