Enclosed please find the original of our request for a two-year waiver of Rule 25-24.515 (13), F.A.C. which we ask you file in the above captioned matter.

We request that pay telephones located at the addresses below be exempt for a two year period from the provisions of Rule 25-24.515(13), Florida Administrative Code, which requires that all pay telephone stations must allow incoming calls to be received "with the exception of those located at penal institutions, hospitals and schools and at locations specifically exempted by the Commission". 




