I am writing with respect to DOCKET NO. 010463-TC.

Enclosed you will find a check for \$65.00 which includes a past due \$3.00 charge for 1999, as well as the form.

James M. Sprinkle has taken appropriate steps to remedy this late status. In 1999, he did not know what he was doing, and therefore it was late. This year, he gave me (his wife) the job of turning it in. I am a mathematics teacher at Lake Brantley High School, and have been there for 21 years. He told me that this was an important bill to pay, but it just went out of my head. I did not pay it, and am now trying to do what I should have done months ago. Now that I know better, this will NEVER happen again because I have programmed the computer to remind me in mid-December to make sure the form has been received and again in January to send a reminder message around mid-January that the RAF is due by January 30.

We realize that there is normally a \$500 fine associated with this rule violation. We are hoping that the Commission will accept a \$100 settlement in lieu of the fine.

Jim waives the objection to the administrative cancellation of his certificate in the event his offer is accepted and he fails to comply with the terms which are offered.

I sincerely hope Jim's good status can be reinstated. Again, this will NEVER happen again.
