Pursuant to a Settlement Agreement entered into on October 30, 2001, Sprint hereby withdraws its August 21, 2001 letter terminating the Florida Interconnection Agreement between Sprint-Florida, Incorporated and MCImetro Access Transmission Services, Inc. Accordingly, within 5 days of MCImetro's receipt of this letter and in accordance with the Settlement Agreement, MCImetro will voluntarily dismiss its petition in Docket No. 011177-TP.
