

1. On August 13, 2002, Florida Competitive Carriers Association ("FCCA") and Mpower Communications Corporation ("Mpower") served their First Set of Interrogatories (Nos. 1-19) and First Request for Production of Documents (Nos. 1-5) upon BellSouth. Based on an agreement between parties to a one-week extension to respond, BellSouth filed its Responses to First Set of Interrogatories and First Request for Production of Documents to FCCA and Mpower on September 20, 2002.
