

Notice is hereby given on July 20, 2005 pursuant to Section 367.045, Florida Statutes, by Gistro, Inc., P.O. Box 110131, Naples, Florida 34108, of its application to the Florida Public Service Commission for an initial certificate of authorization for a wastewater certificate and initial rates and charges, for the following territory located in Lee County, Florida:
