RE: Notification of migration of Global Telecom Group dba Florida Phone Service Customers to FLATEL Platform

Dear Sir or Madam:

On behalf of FLATEL, Inc. this letter is to advise the Commission of our intention to migrate the customers of Global Telecom Group dba Florida Phone Service over to our platform and further request of the commission a waiver of rule 25-4.118 in reference to slamming. Respectfully, it is our understanding, based upon review of the applicable statutes and regulations, that this transaction does not require prior Commission approval, as this action is with the customer's best interest in mind.

Mr. Aiman Awida of Global Telecom Group informed us that they would not be able to continue to offer telephone service in the state of Florida at this time and have requested that in order to provide telephone service without interruption to their customers that their entire base of BellSouth customers be transferred to FLATEL, Inc. as quickly as possible. Unfortunately, there is not much time to allow us to obtain written letters of authorizations or third party verifications. It is our understanding that the Customers service will be interrupted by this Friday if the switch is not made.

FLATEL, Inc. has agreed to do this transfer and provide service to the customer for the remainder of their current month of service at no cost to the customer. In an effort to reduce confusion, FLATEL has also adopted the dba Global Telecom with the Florida Department of State Division of Corporation (attached) and is requesting the Commission include it in our records. FLATEL will bill the customer as such with the same pricing and Service Plans. Should the customer choose to continue their service with FLATEL, the customer will be responsible to FLATEL, Inc. for additional service going forward or switch their service to the Carrier of their choice.
