On January 21, 2010, Tampa Electric Company (TECO or Company) filed a petition for approval of revisions to the current standard interconnection agreements for non-export parallel operators, and Tier 1, Tier 2, and Tier 3 customer-owned renewable generators, and associated tariff sheets 8.1015 – 8.1130. On September 24, 2008, the Commission approved TECO's petition for approval of standard interconnection agreements for expedited interconnection of customer-owned renewable generation and associated net metering tariff, by Order No. PSC-08-0624-TRF-EI.<sup>1</sup>
