

2           **CHAIRMAN GRAHAM:** I want to thank you all for  
3 allowing me to do that. Let's call this meeting to  
4 order. This is the agenda conference of Tuesday,  
5 June the 14th. It's about 9:34 a.m. And we are going  
6 to go a little out of order. We're going to take Item  
7 Number 4 last, but everything else should go pretty much  
8 in order.

9           We have a Move Staff List. A very short  
10 one, but we have one. We have Items Number 1,  
11 Number 10, and Number 12.

13           **COMMISSIONER EDGAR:** Thank you, Mr. Chairman.  
14 I move staff recommendation on Items 1,  
15 10, and 12.

16           **CHAIRMAN GRAHAM:** It has been moved and  
17 seconded. Any further discussion on 1, 10, and 12.

19           **COMMISSIONER BROWN:** Thank you, Mr. Chairman.  
20 I did want to just point out on Item 10 -- I wanted to  
21 commend the parties, FPUC and Gulf, for coming to this  
22 amendment. I believe that the customers are receiving  
23 more of a benefit in cost savings than under the current  
24 contract, and it certainly serves the public interest  
25 well.

1                   **CHAIRMAN GRAHAM:** Thank you. Anything else?  
2                   Commissioner Balbis.

3                   **COMMISSIONER BALBIS:** Thank you, Mr. Chair.  
4                   I want to reserve my comments for the  
5 other items pertaining to Item 12 that will also  
6 pertain to 12, so I will reserve my comments, but it  
7 will not affect the approval of the item.

8                   **CHAIRMAN GRAHAM:** Okay.

9                   **MR. WRIGHT:** Mr. Chairman, I apologize. Schef  
10 Wright, I represent the City of Marianna; I would like  
11 to speak briefly to Item 10. I was not aware this was  
12 going to be a move staff. I just wanted to apprise the  
13 Commission that we will be protesting that item, the  
14 City of Marianna, as an intervenor party. I thought  
15 there would be discussion, but I've said what I need to  
16 say. Thank you, sir.

17                   **CHAIRMAN GRAHAM:** Okay. Thank you. Okay.  
18 All in favor say aye.

19                   (Vote taken.)

20                   **CHAIRMAN GRAHAM:** Any opposed?

21                   By your action, you have approved Move  
22 Staff on Item 1, 10, and 12.
