Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company (TECO or Company) requests confidential classification of certain information and motion for temporary protective order filed in the above-referenced docket, dated April 30, 2025.

The Company is claiming confidentiality of its filing under Section 366.093(3)(d), F.S. Per the Statute, propriety of confidential business information includes, but is not limited to: Subsection (d) “[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms.’

More specifically, the information contains pricing data for coal purchases and transportation charges between TECO and various counterparties. The negotiated pricing/contracts are not publicly known, and disclosure of this information would negatively impact the Company’s ability to negotiate favorable terms in the future, to the detriment of TECO and its customers. Furthermore, the Company requests that the confidential information be protected from disclosure for a period of 24 months.

Staff has reviewed the Company’s information, confidentiality request, and motion for temporary protective order. It is staff’s opinion that the information subject to this request meets the criteria for confidentiality contained in Section 366.093(3)(d), F.S.
