Please find enclosed Florida Utility Services 1, LLC (FUS1) response to Commissions Staff's request for additional clarification and justification for our request for proforma salary inclusions for our field employees in the above-mentioned dockets.

The attached schedule clarifies our original request in these proceedings. The schedule includes the requested employees, their positions, requested salaries, and, duties, along with the associated overall payroll tax calculation. We have also included the calculation to allocate the respective salary and payroll tax amounts for the Alturas Water and West Lakeland Wastewater SARC's.

The attached schedule contains two significant changes to improve operations that will allow this company to operate more efficiently, lowering overtime costs and allowing a more proactive approach as opposed to a reactionary approach that always costs more money.

- 1) FUS1 plans to elevate our more experienced Maintenance Technician to the level of Operations Supervisor with a base salary of \$65,031. This position will supervise, manage and schedule the remaining field staff technicians, and, he will be responsible for overseeing the daily field operations of all the FUS1 systems. Additionally, the Operations Supervisor would oversee tasks like chlorine and other chemical deliveries, hurricane season events and generators, purchasing of supplies, project management, as a bridge between utility office personnel and the field techs, and the scheduling of projects and their completion. The Operations Supervisor would be available to fill in if field tech is sick or on vacation etc.
  - 2) FUS1 requests one new entry level Maintenance Tech position with a base salary of\$52,582. This new position will maintain the number of field technicians servicing FUSI's 19 water and wastewater systems at 4 employees. Our justification for this salary level was based on an independent salary compensation study that was provided in our LARI filing in Docket No.

20220185-WS, Commission Document No. 10932-2022. FUS 1 currently operates and maintains 13 water and 3 water and wastewater systems (19 systems total) located throughout the state of Florida, serving approximately 3,716 customers. While the number of systems FUS1 manages has remained constant since 2021, the complexity and level of services provided by our field staff technicians to properly and timely maintain those systems has changed. FUSI has increasingly relied on existing employee overtime, and on outside contractors to " fill in the gap" for services that could be provided "in house" which tends to increase the overall cost to serve our customers. Additionally, with our systems in Columbia County having come under Commission jurisdiction, we anticipate increased operating and reporting requirements for those systems going forward.
