By Order No. PSC-2025-0087-PAA-WS, issued March 24, 2025, in Docket No. 20240104-WS, the Florida Public Service Commission (Commission) approved the grandfather certificate application and issued Certificate Nos. 685-W and 584-S for Tarawood Utilities, LLC (Tarawood) water and wastewater systems, respectively. The monthly water and wastewater rates you were paying to Tarawood will remain unchanged unless and until a change is approved by the Commission. The Commission reclassified the readiness to serve charge to a guaranteed revenue charge. Additionally, the Commission also removed the meter replacement charge, as it was deemed obsolete. The Commission conformed the miscellaneous service charges pursuant to Rule 25-30.460, Florida Administrative Code. The new changes are set forth below.
