Staff has completed its initial review of your application and has determined that Citrus Waterworks, Inc. (Citrus or Utility) is eligible for a staff-assisted rate case (SARC). The filing fee for this rate case is \$1,000 based on the capacity of the Utility's system as provided by Section 367.145(2), Florida Statues (F.S.) and Rule 25-30.020(2)(t), Florida Administrative Code (F.A.C.). The Utility has remitted an initial payment of \$500 and is required to submit an additional \$500. The remaining filing fee must be received by June 19, 2025, which will be the official filing date for this rate case. Pursuant to Rule 25-30.455(7), F.A.C., the Commission will deny the application if a Utility does not remit the filing fee within 30 days after official acceptance.

Please forward a copy of Citrus's application for a SARC to the Chief Executive Officer of Citrus County as required by Section 367.091(2), F.S., which states:

Upon filing an application for new rates, the utility shall mail a copy of the application to the chief executive officer of the governing body of each county within the service areas included in the rate request. The governing body may petition the Commission for leave to intervene in the rate change proceeding and the Commission shall grant intervener status to any governing body that files a petition.
