7	LLC, for the closure and eventual termination of
8	the My Energy Bill+ Program.
9	The My Energy Bill+ Program is a fixed bill
10	program that allows Duke to have limited control of
11	a participating customer's thermostat. In exchange
12	for this control, participating customers pay a
13	fixed monthly bill for a year with no true-up
14	costs.
15	Duke stated that after sending over 350,000
16	customers multiple direct marketing offers, only
17	142 customers enrolled in the program. As a
18	result, Duke is seeking to close and terminate the
19	program due to a lack of customer interest.
20	Duke stated that if approved, the utility
21	would work with customers to transition them to an
22	alternative rate schedule. Customers will be
23	transferred to the Fixed Bill Program, Budget
24	Billing or return to their previous standard rate
25	schedule.

-	Staff believes that the proposal is reasonable
2	and recommends approval. If approved, the program
	will be closed to new customers as of August 1st,
4	4 2025.
