2 CHAIRMAN LA ROSA: Let's move to Item No. 21.

3 Mr. Kelley, you are recognized, sir.

4 MR. KELLEY: Good afternoon, Commissioners.

5 Patrick Kelley with the Division of Economics.

6 Item 21 is a joint petition by Florida Public  
7 Utilities Company and Florida City Gas seeking  
8 approval of tariff changes to standardize and align  
9 the companies' transportation service programs, and  
10 for approval of a flexible gas tariff for Florida  
11 City Gas.

12 The companies are not proposing any rate  
13 changes at this time. Instead, the parties state  
14 this petition is an ongoing effort to eliminate  
15 inconsistencies and to standardize their individual  
16 transportation service programs.

17 Staff has reviewed the proposed tariff changes  
18 and flexible gas tariff and believes that they are  
19 reasonable, therefore, staff recommends that the  
20 Commission should approve the proposed tariff  
21 changes and FCG's proposed flexible gas service.

22 If approved, FPUC's tariffs will be effective  
23 30 days from the date of the Commission vote.

24 For FCG's tariffs, the company has requested  
25 that they will notify staff of the final

1 implementation date for administrative approval of  
2 the changes to the tariffs no earlier than  
3 September 1st, 2025.

4 Thank you.

5 CHAIRMAN LA ROSA: Excellent. Thank you.

6 Commissioners, any questions on Item No. 21?

7 Seeing no questions, seeing no discussion,


