Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company (FPL or Company) filed a request for confidential classification of Document No. 03448-2025 on May 6, 2025. This document contains information provided in response to Staff's Eighth Set of Interrogatories (No. 172). On May 20, 2025, FPL filed a notice of partial withdrawal of its request for confidential classification of the information provided in Document No. 03448-2025, specifically the material included as Attachment 1 of the Company's response to Staff's Interrogatory No. 172. Therefore, this memo only pertains to the remaining material included as Attachment 2 of the response. The confidential information contained within Attachment 2 can be described as bids and pricing of components for battery storage projects.

In its request for confidentiality, FPL asserts that disclosure of this information would harm FPL, as the information relates to bids or other contractual data and proprietary confidential business information. Furthermore, FPL states that the Company treats the information provided in Attachment 2 of Document No. 03448-2025 as private and has not publicly disclosed it. If disclosed, it may impair the Company's ability to contract for goods and services on favorable terms and also impair the competitive business of the provider of the information.

Staff has reviewed FPL's confidentiality request and agrees that the nature of the information contained in Attachment 2 meets the requirements set forth in Section 366.093(3)(d) and (e), F.S., whereby disclosure of the information would impair FPL's ability to contract for goods or services on favorable terms and impair the competitive business interests of FPL. Therefore, staff recommends that the request for confidentiality of certain information included in Attachment 2 of Document No. 03448-2025 be approved.
