

Pursuant to Florida Administrative Code ("F.A.C.") Rule 25-22.006(3)(a), Florida Power & Light Company ("FPL") hereby files this Notice of Intent to Request Confidential Classification ("Notice"). This Notice relates to confidential information which Florida Energy for Innovation Association ("FEIA") has advised will be included within its direct testimony and exhibits of FEIA's witness Mohamed Ahmed, Ph.D. to be filed today, June 9, 2025. Based upon communications with counsel for FEIA, FPL reasonably anticipates that information contained in the direct testimony and exhibits of FEIA witness Mohamed Ahmed, Ph.D., will include confidential information. Classification specifying those portions of the direct testimony and exhibits which FPL asserts is entitled to confidential treatment within 21 days.
