Pursuant to Sections 366.093(3)(a), and 366.093(e), Florida Statutes (F.S.) and Rule 25-22.006, Florida Administrative Code, Peoples Gas System, Inc. ("PGS") requests confidential classification of certain information provided in response to Staff's 3rd Set of Interrogatories (Nos. 15-23); specifically, the response to interrogatory No. 17. The document number for the confidential filing is 03934-2025, and the document number for the request for confidential classification is 03932-2025.

PGS's response to staff interrogatory No. 17 contains information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information. The information for which confidentiality is sought includes proprietary third-party Consumer Price Index forecasts that PGS utilizes. Disclosure of this information would allow duplication of this entity's work without compensation for their efforts.

Staff has reviewed PGS's confidentiality request and agrees that the nature of the information meets the requirements set forth in Sections 366.093(3)(a) and 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 03934-2025 be approved.
