This letter is to request that the Florida Public Service Commission notify the Universal Service Administrative Company (USAC) and the Federal Communications Commission (FCC) that CenturyLink of Florida, Inc. d/b/a CenturyLink and CenturyLink Communications, LLC ("Companies") are eligible to receive federal high-cost (Connect America Fund) support in accordance with the above-referenced statute and federal rule.

Please find enclosed an affidavit attesting that the Companies only used support received in Florida during the preceding calendar year and will only use support received in Florida in the coming calendar year for the provision, maintenance, and upgrading of facilities and services for which support is intended. CenturyLink anticipates it will relinquish its RDOF support for Florida in 2025.
