First, let me say Thank you for being an awesome Governor! We appreciate all that you have done, and do for us.

I am writing today to ask you to have someone review all the rate hikes of TECO power. My husband has had four strokes and I am the sole caretaker, property manager. I keep our home on minimal use of power. Only a light on in immediate room we are in. One TV, AC set at 76-77 and only down to 75 for sleeping. We used less kwh this year for June and this year our electric bill was \$200 more for June, same period as last year, with less usage. It's getting ridiculous! Out June electric bill was \$726.00!!! We are on Social security. I understand next two years TECO had approvals for more rate hikes. Does tgat mean in 2 years my monthly summer Electric will be \$1K??? Please sir, we need help!! People cannot afford the Property Insurance hikes, the Property Taxes and the utilities at this rate.

We would greatly appreciate someone helping the average person with simple daily expenses. I think an audit for what we're being charged may be in order with respect to utilities!

Please sir, I'm not alone in this matter. On our next door neighbor app there are many in my situation. We certainly need your help sir.
