The Florida Office of Public Counsel, Florida Rising, the Environmental Confederation of Southwest Florida, the League of United Latin American Citizens, and Floridians Against Increased Rates, Inc., ("Joint Parties") object to a continuance of the hearing currently scheduled for Monday, August 11, 2025 at 1:00 p.m. regarding FPL's petition for a rate increase in PSC Docket 20250011-EI.
