**Subject:** Docket No. 20250052-WS OPC Letter of Concerns for Commission Staff's Recommendation on CSWR Interim Request

Good afternoon, all.

To follow-up on the OPC August 28, 2025-letter, the impact of our recommended non-used & useful and bad debt expense adjustments, consistent with the Final Order No. 22-01 by the Citrus County Water and Wastewater Authority (CCWWA), reduce of the Commission Staff's calculated revenue requirements by \$17,738 for water and \$54,616 for wastewater in the "RevRq" tab of the Excel file for Rolling Oaks provided to the OPC. The OPC recognizes that the Commission Staff recommended interim revenue increases for water of 33.10% and wastewater of 8.54% are not changed because the Staff has properly limited them to the revenue requirement amounts requested by the Utility. Although the OPC's adjustments do not change the Commission Staff recommended interim revenue requirements for Rolling Oaks in the instant case, there could be a different outcome for the other 12 utilities previously regulated by the CCWWA that the Commission now regulates, as well as the utilities that Columbia County previously regulated that the Commission now regulates, if any of them file for an interim rate request in the future. For this reason, the OPC urges that the Commission recognize the CCWWA adjustments for interim purposes in this case.
