Pursuant to Section 366.093, Florida Statutes (F.S.) and Rule 25-22.006, Florida Administrative Code, Peoples Gas System (PGS or Company) requests confidential classification for highlighted information appearing in its response to Staff's Tenth Request for Production of Documents (PODs) No. 32, dated September 30, 2025.

The Company is claiming confidentiality for information appearing in its response to Staff's Tenth Request for PODs, No. 32 under Section 366.093(3)(e), F.S. Per the Statute, proprietary confidential business information includes, but is not limited to: Subsection (e) "Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of information."

PGS stated in its confidentiality request (Document No. 14103-2025) that the information provided in Document No. 14102-2025 for which confidential treatment is being sought, includes information relating customer identifying information which constitutes competitive interests of PGS or the provider of the information, the disclosure of which would impair the competitive business of PGS or the provider of the information. Specifically, the information contains detailed locations of PGS's customers. Disclosure of this information would impair the provider of the information and the efforts of PGS's competitive business.

Staff has reviewed the highlighted information provided in PGS's response to staff's Tenth Request for PODs, No. 32 (Document No. 14102-2025), as well as the Company's confidentiality request (Document No. 14103-2025). In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality contained in Section 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidentiality of information included in Document No. 14102-2025 be approved.
