To Whom It May Concern -

On Tuesday, October 14, 2025, Food & Water Watch submitted an elected official sign on letter opposing the FPL rate hike proposal. Earlier this week, Charlotte County Commissioner Bill Truex responded to that letter submission with concern about his name being on the letter. We immediately contacted his office to address the concern.

On Tuesday, October 21, 2025, I spoke with Diane Whidden, Commissioner Truex's Professional Assistant. Food & Water Watch had several recorded email exchanges (7/23/25, 8/15/25, 9/11/25, 10/1/25) and one phone call (8/15/25) with Commissioner Truex's office between 7/23/25 and 10/1/25. Ms. Whidden confirmed that she also had a record of these communications.

On the 8/15/25 phone call, Ms. Whidden told a Florida staffer that she would bring the sign on letter request to Commissioner Truex's attention. On October 1, 2025, at 9:26 am, we sent a follow-up email to Commissioner

Truex at Bill.Truex@CharlotteCountyFL.gov (email attached). At 10:40 am that same morning, we received a timestamped response to the sign on letter request with Commissioner Truex's name, elected office, phone number and email address confirming the addition of his name to the letter opposing FPL's rate hike. Ms. Whidden confirmed they received the email October 1, 2025, and that the information on our timestamped form was accurate, but she said that, to her knowledge, no one in their office had completed the form or authorized the sign on. She also confirmed that only she and Commissioner Truex have access to his email account. I assured Ms. Whidden that we would file an amended letter with Commissioner Truex's name removed, given their position regarding the letter.

I also inquired with Ms. Whidden about the "one other Commissioner" mentioned in Commissioner Truex's email to the PSC. She said that she did not have the name of the commissioner. I asked her to contact me if they were able to identify who Commissioner Truex was referring to, and let Ms. Whidden know that we would readily provide an amended letter removing the alleged commissioner, if we were so notified. We have not received any further communication on the matter.

Please accept the amended sign on letter (below) from 29 Florida elected officials opposing Florida Power & Light's requested rate increase, removing Commissioner Truex's name, but adding State Representative Daryl Campbell and Oakland Park City Commissioner Aisha Gordon who have both signed on since the originally filed letter.

# Florida Elected Officials Oppose FP&L's \$10 Billion Rate Hike Request

Dear Governor DeSantis and the Florida Public Service Commissioners,

We, the undersigned elected officials, write to urge the rejection of Florida Power and Light's (FP&L) proposed nearly \$10 billion rate increase — the largest in US history. This is coming at a time when many of our communities are still recovering from the economic hardships related to inflation and the devastating storms that have pummeled our state. Our communities can't afford the burden of additional unfair utility rate increases.

Specifically, we ask the Governor and the Florida PSC to oppose:

- Long-term rate hikes that lack a fully transparent, cost-effective, and data-driven plan focused on safe and reliable energy at fair and reasonable prices;
- A return on equity well above the national average, pulling higher profits from Floridians to benefit shareholders. FP&L's current request would yield a return on equity of 11.9% well above the national industry average of 9.6%; and,
- Continued investments in costly methane gas infrastructure, which locks customers into volatile fuel
  costs instead of transitioning to a diversified energy mix that would enhance energy security and longterm cost-savings.

Our PSC Commissioners are charged with balancing the needs of the utility with the needs of consumers. FP&L's proposal, however, prioritizes widening profit margins without considering the millions of Florida families, seniors, and small businesses struggling with rising bills. The state Office of Public Counsel, in fact, recently filed expert testimony that only \$105.6 million of FPL's \$9.8 billion request is just fiable. Floridians deserve better. The PSC is charged with ensuring safe, reliable, and affordable utility service—not supporting unchecked corporate profits for a monopoly utility (Ch. 366, F.S.). In order to protect our

communities and ensure long-term energy resilience, we urge you to act in the best interest of Floridians and reject FP&L's rate hike request.
