### **Promotion Description**

## Large and Small Business MegaLink<sup>®</sup> Interoffice Promotion

#### **Overview**

The MegaLink Interoffice promotion is scheduled to begin on May 1, 2006, and end on December 31, 2006. For qualifying business subscribers who sign a 24-month or longer contract term agreement for a MegaLink point-to-point circuit, this promotion offers a waiver of the nonrecurring charges for the digital local channel, interoffice channel, service establishment and premise visit. This promotion also offers a credit on the mileage-sensitive interoffice channel monthly recurring rates. Existing subscribers may participate in this promotion if the customer's existing term election is within six (6) months of expiration.

#### Promotion Specifics
