Smart Choice Communications, LLC has requested cancellation of Certificate No. 8941, effective April 10, 2025. The certificate holder has complied with Section 364.335(3), Florida Statutes, by providing the Florida Public Service Commission notice in writing of its request for voluntary cancellation of its certificate.

Neither the cancellation of the certificate nor the failure to receive a Regulatory Assessment Fee (RAF) return notice shall relieve Smart Choice Communications, LLC from its obligation to pay RAFs. This includes the obligation to pay any penalty and interest that may be due for the current year. Failure to pay the amounts owed to the Florida Public Service Commission will result in the Company's fees, penalties and interest being sent to a collection agency.

Pursuant to Section 2.07.C.5.f., Administrative Procedures Manual, the voluntary cancellation is acknowledged and the docket should be closed.

RE: Smart Choice Communications, LLC, TY176, Certificate of Authority Termination Notice

Dear Mr. Teitzman:

Pursuant to Fla. Stat. § [364.335\(3\)](#) (2024), Smart Choice Communications, LLC (“SCC”) notifies the Florida Public Service Commission (“Commission”) of its termination of its Certificate of Authority¹ to provide telecommunications services in Florida and withdrawal of its telecommunications tariff, effective immediately. SCC’s termination of its Certificate of Authority and tariff withdrawal is predicated on the Company’s transition to voice over Internet protocol (“VoIP”) telephony. In support of its termination notice, SCC states as follows.

SCC has ceased in the provision of telecommunications services in Florida, maintains no telecommunications service subscribers in Florida, and no longer requires a Certificate of Authority, accordingly. Further, SCC:

- does not maintain carrier of last resort status
- does not owe monies to any of Florida telecommunications Public Purpose Programs associated with the provision of telecommunications services
- has complied with all applicable regulatory obligations including submission of its annual report and reporting/payment of regulatory fees and
- has no outstanding customer complaints filed with the Commission nor enforcement actions.
