ORDER GRANTING EXTENSION OF TIME

On August 27, 1987, we issued Order No. 18066 in Docket No. 870248-TL, which, among other things, required Central Telephone Company of Florida (Centel) to file a revised tariff to reflect the Toll-Pac rate structure for the Ponce de Leon-to-Bonifay route by September 28, 1987.

On September 21, 1987, Centel notified us that the route between the exchanges is interLATA and "belongs" to AT&T. Centel has requested clarification of the following:

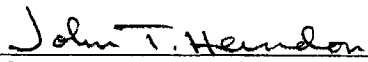
1. If the toll traffic belongs to AT&T, can the Commission order Centel to implement Toll-Pac on the route?
2. Since the route is intracompany, should the toll traffic belong to Centel even though it is interLATA?
3. When LEC Toll Bill and Keep is implemented on January 1, 1988, will this route belong to Centel as an intracompany route or to AT&T as an interLATA route?

We find it appropriate to grant Centel an extension until such time as the interested parties can determine the appropriate serving arrangement.

It is, therefore

ORDERED by Commissioner John T. Herndon, as Prehearing Officer, that Central Telephone Company of Florida shall be granted an extension of time as a result of the concerns identified in the body of this order.
