ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated April 14, 1997, Citizens Telecommunications Company, Inc. d/b/a Citizens Telecom, holder of Interexchange Telecommunications Certificate of Public Convenience and Necessity Number 4465, requested that Certificate Number 4465 be amended to reflect the fictitious name, Citizens Telecommunications Company, Inc. d/b/a Citizens Communications Company. Upon review of the Department of State, Division of Corporations' records, it appears that Citizens Telecommunications Company, Inc. d/b/a Citizens Telecom has properly registered the fictitious name. Accordingly, we find it appropriate to amend Certificate Number 4465 to reflect the new operating name.

This Order will serve as Citizens Telecommunications Company, Inc. d/b/a Citizens Communications Company's amended Interexchange Telecommunications Certificate of Public Convenience and Necessity Number 4465. Citizens Telecommunications Company, Inc. d/b/a Citizens Communications Company should retain this Order as evidence of the name change.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Citizens Telecommunications Company, Inc. d/b/a Citizens Telecom to change the name on Certificate Number 4465 from Citizens Telecommunications Company, Inc. d/b/a Citizens Telecom to Citizens Telecommunications Company, Inc. d/b/a Citizens Communications Company is hereby approved. 

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
