NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING CERTIFICATE OF AUTHORITY

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code (F.A.C.).

382 Networks, Inc., (382 Networks) has applied for a Certificate of Authority, pursuant to Section 364.335, Florida Statutes (F.S.). Upon review of the application, it appears that 382 Networks has sufficient technical, financial, and managerial capability to provide such services. Accordingly, we hereby grant Certificate No. 8824 to 382 Networks. The certificate authorizes 382 Networks to provide telecommunications services throughout the State of Florida.

If this Order becomes final and effective, it shall serve as 382 Networks' certificate. Therefore, 382 Networks shall retain this Order as proof of certification. We are vested with jurisdiction over this matter pursuant to Sections 364.33 and 364.335, F.S.

Telecommunications providers are subject to Chapter 364, F.S., and Rule 25-24, F.A.C., and are required to comply with all applicable provisions of Chapter 364, F.S., and Rule 25-24, F.A.C.

In addition, under Section 364.336, F.S., certificate holders must pay a minimum annual Regulatory Assessment Fees (RAFs) if the certificate was active during any portion of the calendar year. A RAFs Return notice will be mailed each December to 382 Networks for

payment by January 30th. Neither the cancellation of the certificate nor the failure to receive a RAFs Return notice shall relieve 382 Networks from its obligation to pay RAFs.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that 382 Networks, Inc.'s application for a Certificate of Authority is hereby granted. It is further

ORDERED that 382 Networks, Inc., is awarded Certificate No. 8824, which authorizes 382 Networks, Inc., to provide telecommunications services throughout the State of Florida. It is further

ORDERED that 382 Networks, Inc., shall retain this Order as its proof of certification. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed.
