NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING CERTIFICATE OF AUTHORITY

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Unity III Telecom, LLC (Unity III) applied for a Certificate of Authority to provide telecommunications services, pursuant to Section 364.335, Florida Statutes. We are vested with jurisdiction on this matter pursuant to Sections 364.33, 364.335, and 364.336, Florida Statutes.

Upon review of the application, it appears that Unity III has sufficient technical, financial, and managerial capability to provide such service. Accordingly, we hereby grant to Unity III a Certificate of Authority No. 8826, which authorizes Unity III to provide telecommunications services in Florida.

Telecommunications service providers are required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapters 25-4 and 25-24, Florida Administrative Code.

Under Section 364.336, Florida Statutes, Certificate of Authority holders must pay a minimum annual Regulatory Assessment Fee (RAF) if the certificate was active during any portion of the calendar year. A RAF Return notice will be mailed each December to Unity III

for payment by January 30th. Neither the cancellation of its certificate nor the failure to receive a RAF Return notice shall relieve Unity III from its obligation to pay its RAF.

If this Order becomes final and effective, it will serve as Unity III's certificate. Unity III shall retain this Order as proof of its certification.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Unity III Telecom, LLC's application for a Certificate of Authority is hereby granted. It is further

ORDERED that Unity III Telecom, LLC is awarded Certificate of Authority No. 8826, which authorizes Unity III Telecom, LLC to provide telecommunications services throughout the State of Florida, subject to the terms and conditions set forth in the body of this Order. It is further

ORDERED that this Order shall serve as Unity III Telecom, LLC's certificate and shall be retained by Unity III Telecom, LLC as proof of certification. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed.
