NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING CERTIFICATE OF AUTHORITY TO PROVIDE LOCAL TELECOMMUNICATIONS SERVICE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Nebula Telecommunications of Florida, LLC (Nebula) applied for a Certificate of Authority to provide local telecommunications service, pursuant to Section 364.335, Florida Statutes. Upon review of the application, it appears that Nebula has sufficient technical, financial, and managerial capability to provide such service. Accordingly, we hereby grant to Nebula a Certificate of Authority No. 8831, which authorizes Nebula to provide local telecommunications service throughout the State of Florida.

Telecommunications service providers are required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapter 25-4, Florida Administrative Code.

In addition, under Section 364.336, Florida Statutes, Certificate of Authority holders must pay a minimum annual Regulatory Assessment Fee (RAF) if the certificate was active during any portion of the calendar year. A RAF Return notice will be mailed each December to Nebula for payment by January 30th. Neither the cancellation of its certificate nor the failure to receive a RAF Return notice shall relieve Nebula from its obligation to pay its RAF.

If this Order becomes final and effective, it will serve as Nebulas' certificate. Therefore, Nebula shall retain this Order as proof of its certification. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.336, Florida Statutes UMENT NUMBER-DATE
