FINAL ORDER APPROVING CHANGE IN NAME OF UTILITY

BY THE COMMISSION:

In response to a Commission staff interrogatory in Docket No. 20250146-WS, Useppa Island Utility, Inc. (Utility) indicated that an incorrect name was inadvertently used when registering with the Commission.¹ The regulated history of the Utility began in 1981 when the Utility was granted water and wastewater certificates 354-W and 310-S in Lee County under the name Useppa Island Utility, Inc. (Original Certificate Name). However, the Utility was registered with the Florida Department of State, Division of Corporations, on March 23, 1981, as Useppa Island Utilities Company, Inc. (Corporate Name). Subsequent filings with the Commission have reflected variations of the Utility's Original Certificate Name and Corporate Name. On February 23, 2026, Commission staff established Docket No. 20260029-WS to correct the Utility's name for the agency's records.

Rule 25-30.039, Florida Administrative Code (F.A.C.), sets forth the filing requirements for changes in name only, with no change in the ownership or control of the utility or its assets. On March 2, 2026, the Utility filed an affidavit for acknowledgement of the name change of the Utility from its Original Certificate Name to its Corporate Name. The Utility provided a statement attesting that there will be no change in the ownership, assets, or control of the Utility, and that the name on file with the Florida Department of State, Division of Corporations is the correct name. The Utility provided documentation from the Florida Department of State that it has continuously been registered and operated under the Corporate Name since 1981. On May 1, 2026, the Utility filed an affidavit stating that it mailed the approved customer notice to its customers. Having reviewed the Utility's filings, the request for acknowledgement of change in name is in compliance with the provisions of Rule 25-30.039, F.A.C. Therefore, the name on Certificate Nos. 354-W and 310-S shall be changed from Useppa Island Utility, Inc. to Useppa Island Utilities Company, Inc., as reflected on the certificates identified in Attachment A of this Order.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Useppa Island Utilities Company, Inc. to change its name on Certificate Nos. 354-W and 310-S is hereby approved, and issue this administrative order to acknowledge the change in name of the

certificates identified in Attachment A. This Order shall serve as the Utility's certificate and shall be retained by the Utility. It is further

ORDERED that this docket be closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Office of Commission Clerk, and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
