### **EXECUTIVE SUMMARY**

## **Description of Proposed Tariff**

The purpose of this filing is to clarify tariff language in the General Subscriber Service Tariff, Section A2.10 Special Promotions, for the 2004 Key Customer Promotion.

The proposed tariff language clarifies the following:

- (1) In the event the subscriber terminates the term election agreement, the subscriber agrees to pay liquidated damages to BellSouth as provided in the tariff, plus any special promotional rewards received. The new language specifies that the special promotional rewards apply to non-recurring onetime rewards provided for signing up for the 2004 Key Customer Program.
- (2) Additional new language clarifies that subscriber's who will not be assessed termination charges must maintain some level of local regulated service with BellSouth *under this agreement*, for the agreed upon term.
- (3) Language is added to specify that BellSouth will provide written and/or verbal reminders to the subscriber of the term election agreement expiration date and the automatic renewal provision beginning approximately 180 days prior to its expiration.

The proposed effective date of this filing is July 23, 2004.

If the Subscriber does not renew the Agreement for another term or at the expiration of the renewed term, the Subscriber agrees to pay full tariffed charges for services.
