Chairman Beard has assigned me to sit as one member of the panel in Docket No. 891194-TL. Because I had a very limited involvement in this docket while employed at the Office of Public Counsel (OPC), I believe it appropriate to disclose the extent of my participation. I was responsible for the hiring of Dr. Mark N. Cooper as an expert witness for this case. My duties related to the administrative details of this contract. I did not discuss substantive issues with the witness nor the substance of his testimony. The above actions constitute my total involvement in this docket while employed with OPC. I am thus unfamiliar with the facts and issues involved in this docket.

I understand that this case has been to hearing and that the Commission has not yet rendered a decision. I will not participate in the Commission's decision in this case unless the Commission is deadlocked on an issue and I am asked to review the record and cast the deciding vote. In that event I believe that I can sit on this case and render a fair, impartial decision based on record evidence. In an abundance of caution, however, I do wish to give the parties an opportunity to object to my participation to eliminate even the appearance of impropriety. I wish to emphasize that any objection to my participation will not result


