AMENDATORY ORDER

BY THE COMMISSION:

By Proposed Agency Action No. 24750, issued July 2, 1991, we proposed to grant increased rates and charges for Lake Utilities, Ltd. (Lake or the utility). On page 4 of that Order, there is a scrivener's error in paragraph "b" which begins as follows: "Expansion of the water treatment plant...." That paragraph should read, "Expansion of the wastewater treatment plant...."

In addition, on page 11 of the above referenced Order, there is a scrivener's error in the description of the Commission Approved Gallonage Charge for Monthly Water Rates. The correct gallonage charge is \$1.62 per 1,000 gallons; there is no gallonage allowance in the base facility charge rate structure. A corrected copy of the monthly rate schedule for water is attached to this Order and incorporated herein. It is, therefore

ORDERED by the Florida Public Service Commission that Order No. 24750 is hereby amended as set forth in the body of this Order. It is further

ORDERED that Order No. 24750 is affirmed in all other respects.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
